





We exist with a purpose



- 5.4 billion kilometres travelled
- 7.9 million distraction events detected, in real-time
- 163 thousand fatigue interventions in the past 12 months alone
- Human Factors science underpins a robust technology that operates in challenging and real-world conditions, RELIABLY
- FACT: drowsy driving increases risk of accident between 4 and 6 X
- FACT: 68% of all road crashes involve some time of observable distraction

Cash at 30 October 2020 of A\$60.8m


US investment of A\$28m shored up balance sheet and sets company up to fully funds current business plan



Automotive

- DMS lauded as key to enabling any level of automation to ensure high levels of driver assistance are balanced by driver engagement levels

Aviation

 - Consoles (Air Traffic Control)
- Momentum advances from proof of concept into commercialization – demonstrated by MOU for nonexclusive global License with L3Harris.








Approval of 2020 Employee Benefits Plan

Ratification of prior share issue (Placement Shares)


