


2017 Company Highlights


- Mike McAuliffe appointed CEO
- Company revenue was more than double FY16 on like-for-like basis total sales revenue in excess of A\$13M
- Australian R&D research grant for Advanced Safe Truck Concept in collaboration with leading transport company, Ron Finemore Transport, Monash University's Accident Research Centre, and now Volvo Trucks Australia
- CAN Drive project sponsored by ACT Government first autonomous driving trial focused on driver behaviour, led by Seeing Machines Human Factors.

Operational Highlights - Automotive

- SEE tech launched in GM Cadillac Super Cruise CT6 2018 worlds first semi-autonomous vehicle featuring FOVIO driver monitoring technology
- Nick DiFiore appointed to lead Automotive business
- Expanding ecosystem of Tier 1 partnerships, eg. Autoliv
- FOVIO DMS platform attracts significant attention as global mandate for driver safety system underpins rapid growth of autonomous driving and vehicle production
- Sales for FY17 grew strongly year on year by >50%.





Operational Highlights - Fleet

- Significant growth in Fleet sales more than 250% that of previous year and over 130 customers globally with first UK customer announced in April
- Total Contract Value increased from A\$7.9M at end of FY16 to A\$36.5M at end of FY17
- Marketing and Distribution Agreement signed with MiX Telematics global leader in fleet solutions with access to commercial fleet customer base
- Geotab, a worldwide leader in fleet telematics solutions, added the Company's Guardian System to the Geotab Marketplace.
- Distribution partners continue to forge growth appointed distributors based in South Africa, Asia, Latin America and Australia

- Exclusive Alliance and Master Development Agreement signed with Progress Rail
